REVIEW OF ENGLISH NATIONAL PARK AUTHORITIES – RELEVANT EXTRACTS FROM THE PEAK DISTRICT NATIONAL PARK AUTHORITY'S RESPONSE TO ALUN MICHAEL ON 9 OCTOBER 2002

Key points in our covering letter

Recommendation 42 – we welcome and look forward to further discussion by DEFRA with National Park Authorities on the refinement of the basis for determining funding allocations based on a recurring needs baseline, and a performance based element (and exceptional pressures). Best Value Performance Plans have highlighted the resource needs to deliver priority work in line with the government's agenda related to National Parks.

Recommendation 46 – is that all National Park grant should come direct from central government rather than, as now, 25% being re-directed via the local authorities. The arguments for and against this seem quite finely balanced. We did not press to change existing arrangements and are aware of concerns about centralisation from some of our Members and from the constituent authorities. We are not pressing for this change, but recognise that if a change is made it is practical. (Note that this recommendation and the responses are still under consideration by Defra).

<u>Summary of the Relevant Defra Recommendations about Sponsorship and Resources and our views which accompanied the letter to Alun Michael</u>

The 2 August 2002 Seminar was for Members of the Authority in advance of consultations with our Stakeholders and a Special Authority meeting on 27 September. ' 'denotes our agreement with recommendations. Points in 'bold' were specific comments from the Peak and the 'suggested next steps' were from Defra, who are now regularly reviewing progress and action with National Park Authorities.
