2. APPOINTMENT OF MEMBERS TO COMMITTEES (A.11/EWJ)

Proposal

This report requests the meeting to appoint Members to the three Standing Committees.

2. RECOMMENDATION:

That Members be appointed to the Planning Committee, Services Committee, and Audit and Performance Committee.

Policy/Legal Background

- 3. The Authority's Standing Committees are Planning Committee, Services Committee, and the Audit and Performance Committee with appointments being made each year.
- 4. The Environment Act 1995 requires that membership of the Committees should as far as possible reflect the make up of the membership of the Authority. This means that the Committees should have a majority of Council appointed Members over the Members appointed by the Secretary of State, which includes Parish Members.

Key Issues

- 5. The agreed composition of each Committee is set out in the Appendix.
- 6. It is proposed that the allocation of places on the Planning Committee be reduced to reflect the recent reduction in the total membership of the Authority. This is shown in Annex 1.
- 7. Members who are not appointed to the Planning Committee are appointed to both the Services Committee and the Audit & Performance Committee.

8. Council Members

The council appointed Members preferences for places on the Planning Committee are shown in Annex 1. Votes will need to be taken to appoint one Member from Derbyshire County Council and two Members for the metropolitan councils and N.E Derbyshire District Council places.

It has been the practice in the past that only council appointed Members vote to fill these places.
