#### **ASSOCIATE MEMBERSHIP FUNCTIONALITY**

**1 Platform benefits:** NONE.

**2 Portal website benefits**

Publication of content on the following sections on the website currently hosted at <http://www.nationalparks.gov.uk> which is hosted by the Portal System:

- News;
- Jobs;
- Events;

Use of secure (HTTPS) pages hosted by the Portal System (but using third party systems and technology provided by Protx Limited), to provide payment functionality for each Associate Member to use as part of the Planning Portal so that visitors to the Planning Portal can pay fees for applications made to such Associate Member under Planning Legislation, or to use to pay for any other services or goods that the Associate Member has provided.

Inclusion in the website index and search functionality hosted by the Portal System, so that visitors to the Portal website can search content on the Associate Members website from time to time.

**3 Other Portal System benefits**

Full use of the extranet that is hosted by the Portal System.

Website knowledge sharing within the community of Members.

Support from the Portal Manager in relation to Associate Functionality.

#### **UMBRELLA MEMBERSHIP FUNCTIONALITY**

**1 Platform benefits**

The same benefits as are provided by Associate Functionality, and use of the following in addition:

- GIS (the geographic information data processing facility that is provided by the Portal System);
- e-Shop (the on-line transaction management facility that is provided by the Portal System); and
- Search engine (the functionality of the search facility that is provided by the Portal System, so that the functionality can be used to support the search facility on the Umbrella Member's own, separately hosted website).

## **2 Portal website benefits**

The same benefits as are provided by Associate Functionality.

## **3 Other Portal System benefits**

Use of the following:

- GIS development as undertaken by the Portal Team (or any member of it) (such development being producing or modifying functionality of the GIS or templates used by the GIS);
- Website knowledge sharing within the community of Members;
- Knowledge sharing within the community of Members regarding website best practice, website useability and website accessibility; and
- Support from the Portal Manager in relation to Umbrella Functionality.

## **FULL MEMBERSHIP FUNCTIONALITY**

### **1 Platform benefits**

The same benefits as are provided by Umbrella Functionality, and use of the following in addition:

- LiveLink Content Management System (the content management system facility that is provided by the Portal System, enabling each Full Member to host its own website via the Portal System and to manage the content of such website);
- The benefit of the managed hosting service provided to the Accountable Body under a contract between the Accountable Body and Titan Internet Limited ("Hosting Service Contract"), or such other supplier as the Governing Body may decide from time to time on terms at least as beneficial to the Members as the terms of the Hosting Service Contract;
- SQL Server space (subject to availability of such space on the Portal System) on the server managed under the Hosting Service Contract for the Full Member to store its content for processing by the LiveLink Content Management System; and
- Web statistics (use of the facility provided by the Portal System for monitoring usage by website visitors of each Full Member's website that is hosted by the Portal System).

The same benefits as are provided by Associate Functionality.

### **3 Other Portal System benefits**

The same benefits as are provided by Umbrella Functionality, and use of the following in addition:

- Knowledge sharing within the community of Members regarding LiveLink;
- Sharing of human-readable source code [for use in LiveLink]; and
- Support from the Portal Manager in relation to Full Functionality.
