B) Travel and Subsistence

C) Payment Index

The amounts paid under the scheme will be indexed for four years from 1 April 2023 to 31 March 2027 as follows:

- Basic Allowance, SRAs, Co-optees' Allowance and Independent Persons annual remuneration are indexed to the annual percentage salary increase for local government employees (at spinal column 43 or the equivalent level if the spinal column points are revised), to be applied from the same year that it applies to employees.
- Travel Allowances including Mileage Rates, and Subsistence Allowances are indexed to the same rate that is applicable to Officers, except the Passenger Supplement Mileage rate.
